Wyatt presented development information for the property owner. He stated the drainage issues will be addressed.

 DISCUSSION and related CONSIDERATION of Ordinance 2019-07 (PC Petition 2019-09), request of Troung Le, to rezone approximately 2.2 acres located at 5909 Aero Dr from O-1 to C-5

Le presented his request for rezoning and discussed his business. Dickson asked if this is a retail business. Le stated no retail only organic growing for wholesale. Littleton asked if there will be any other requirements for building inspections. Young stated no other requirements unless they expand the building. Dickson asked about security. Le stated biometric locks, cameras, interior loading area for vehicles, alarms and monitoring system. Hughes asked about smell. Le stated carbon filters are used in all areas especially during the flowering stage when the smell is the greatest. He stated the carbon will filter the smell.

Motion was made by Smith, seconded by Dickson to approve Ordinance 2019-07 (PC Petition 2019-09), request of Troung Le, to rezone approximately 2.2 acres located at 5909 Aero Dr from O-1 to C-5. Motion carried as follows:

 DISCUSSION and related CONSIDERATION of Ordinance 2019-05 PC (PC Petition 2019-07) regarding amending the Tuttle Zoning Code updating the façade regulations for residential buildings Young presented the Planning Commission reviewed and approved this last Monday to include homes of less than 2000 feet will be required to have brick or masonry wainscoting and any siding shall have 25 year life.

Dickson stated this is increasing the cost and not making housing affordable. This also limits craftsman style homes. Hughes agrees that craftsman is what is being built currently. Dickson stated he does not think the ordinance should be updated. McLeroy stated there is a design review for exceptions included in the ordinance. Littleton stated Jeff Hill said the custom homes they are building currently are craftsman style. Young stated the fear is that smaller homes would use cheap product on the back and sides of the home. He stated a Planned Unit Development would go around the requirement. Dickson asked why change the ordinance if there are reasons and ways to go around it. Littleton stated affordable housing is needed in Tuttle. Dickson stated the City would be limiting the style of homes built if this is approved. His solution would be no changes. Hughes asked about current requirements. Young stated no metal facades unless approved by the board. He stated the Planning Commission was focused on quality building materials.

Motion was made by Smith, seconded by Littleton to remand Ordinance 2019-05 (PC Petition 2019-07) regarding amending the Tuttle Zoning Code updating the façade regulations for residential buildings back to the Planning Commission for further review. Motion carried as follows:

Young stated there has been a break in at the concession stand and the water tower. Slattery stated he is working with PSO for better lighting at the water tower.

Young presented the bond issue work is moving forward. He stated he met with ASCOG about a proposed meeting with other city managers for road improvement with county involved in the work.

Young presented the sales tax report with sales tax decreasing.

Young stated he met with Jaden Court developer and feels confident that they will make the drainage issues better for surrounding developments. He stated the residents in Silver Ridge filled in the back channel causing the drainage to get worse. He stated the city will need the easements and fences moved to improve the drainage.

Dickson asked discussed three solutions to the problem that were provided in the meeting with engineer and developer. Dig the channel on the west side of Deer Ridge, add feeder road at well site; 5 acres of detention pond at Jaden Court, sidewalks connecting to Silver Ridge; and reshape the channel in Silver Ridge.

McLeroy asked that the city propose a resolution next month and notify all residents along the channel by letter.

Young presented this Thursday at 1:30 p.m. is the High School assembly for state champions if anyone would like to attend.

Dickson asked about street signage for truck routes. Slattery stated very close to getting signage installed.

b. Councilmember Reports

Littleton stated met with Avalon and Berkley South neighborhoods regarding annexation and will meet again the last Thursday in March.
