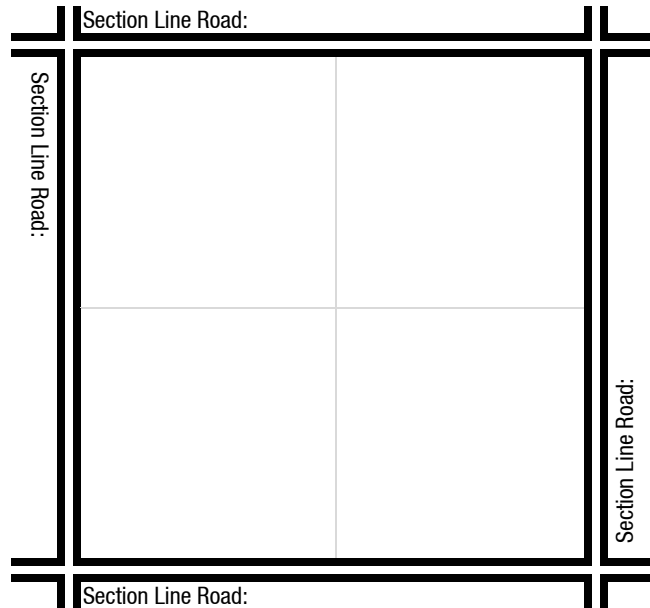

\_\_\_\_\_ If your Application is for a subdivision, MHP, or multi-occupancy structure, it will not be processed without a legible copy of the plat map and/or building plans.

\_\_\_\_\_ Once an address is assigned, a copy of this Application will be sent to the US Postal Service, telephone & power companies & other government agencies so your new address can be set up in their systems.

\_\_\_\_\_ As part of this process, a floodplain determination will be completed. ALL development in the City is subject to the provisions of the City's floodplain ordinances and it Applicant's responsibility to fully comply with them.
